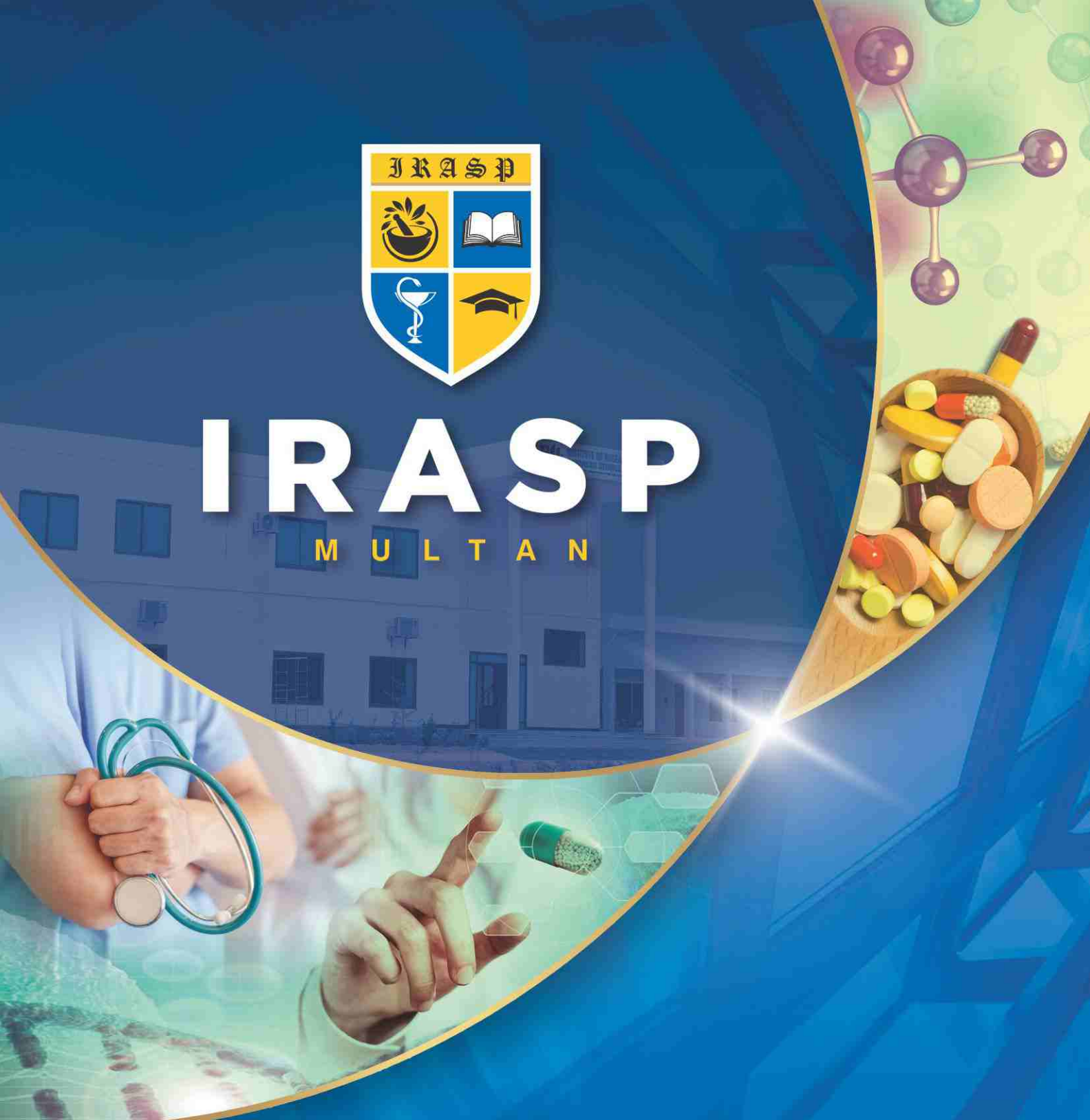

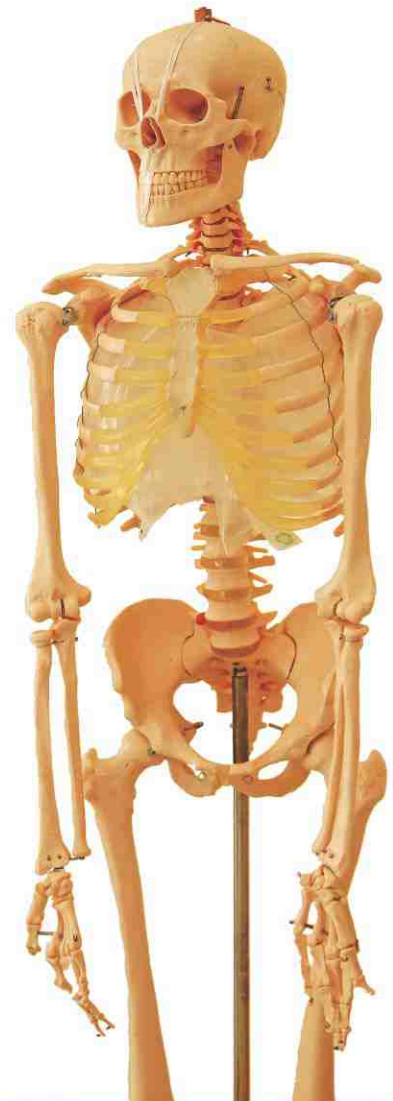

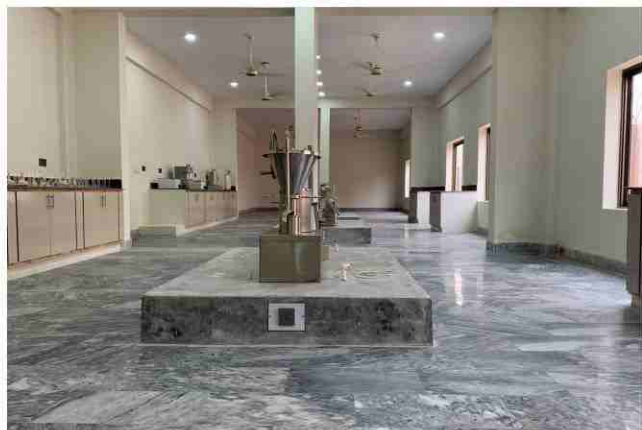

The Vice-Chancellor, **Prof. Dr. Mansoor Akbar Kundi**, inaugurated e-Library of the Institute.

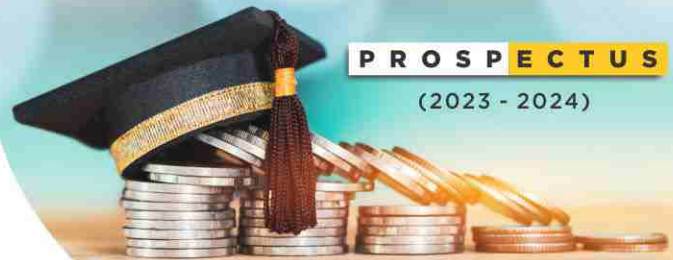

Professional Scope & Career

This Pharm-D degree, Doctor of Pharmacy, is purely a professional degree which is span over five years. After successful completion Pharm-D program, such degree holder can use "Dr." as prefix with his/her name. The scope of pharmacy holds the substantial importance in all over the world. A medical industry is nothing without Pharmacists. Pakistan is also developing in the field of research in pharmacy, therefore, there are enormous opportunities for a researcher in pharmacy in Pakistan. A large number of career opportunities are available for qualified pharmacist in public and private sectors of Pakistan like Hospital Pharmacist, Drug Inspector, Forensic Scientist. They can also go in Drug Testing Laboratories, Drug Regulatory Authority of Pakistan, Health Teaching Institutions and Pharmacy Colleges, Pharmaceutical Industries, Retail or Community Pharmacist, Sales and Marketing, Distribution Centers, NGOs, Health Educators and many more.





Scholarships

The Admission Committee of IRASP in its meeting held on 16.06.2022, approved following Scholarships / Fee Discounts to be given to the talented & Need Based by setting following parameters/criterion:

a) Scholarship/Concession on Talent/Merit Based.

The candidate who has 90% or above marks at F.Sc./Equivalent level will be given 40% Tuition fee relaxation in 1st Professional. Further, the candidate who has 85% to 89% marks at F.Sc./Equivalent level will also be given 20% Tuition fee relaxation in 1st Professional. However, to avail these concessions thereafter 1st Professional, then all such students must secure and maintain at least 65% marks of each of succeeding Professional of the Program. In case, any such student could not maintain at least 65% marks at any stage / professional / year or fails in one or more papers, then this relaxation shall be withdrawn from him/her forthwith, without affecting the previous one(s) granted till that.

b) Scholarship/Fee Relaxation on Need Based.

- (i) Two candidates would be given concession of 50% in Tuition fee in 1st Professional on Need Based, subject to verification. However, to avail this concession thereafter, then these students must secure and maintain at least 55% marks of each succeeding Professional of the Program. In case, any student under this category secures less than 55% marks at any stage / professional / year or fails one or more papers then this concession shall be withdrawn from him/her forthwith, without affecting the previous one(s) granted till that. Moreover, if such student shall found not deserving at any later stage even after verification, then this facility would be withdrawn by making recovery earlier one(s).
- (ii) One orphan student will be given full concession in Tuition Fee. However, in case there would be two or more than two candidates in this category, then only one candidate will be selected for this concession purely in order of merit. The successive candidate under this category would submit undertaking on Stamp Paper that he/she truly deserves this concession, which will also be verified in due course of time by Administration. In case any contradiction is found in declaration, then this facility shall be withdrawn from him/her and earlier one(s) will also be recovered from such candidate.
- (iii) If the guardian of any student unfortunately if passed away during his/her study, then such student will be given 50% Tuition fee relaxation or as decided by the competent authority, thereafter, till completion of the program.
- (iv) If any candidate is physically disabled, then such individual will be eligible for concession of 25% in Tuition fee.

c) Fee Discounts for Other Categories.

- (i) If any candidate is Hafiz-e-Quran, then 20 marks will be added to his/her F.Sc. marks. After addition of these 20 marks, if he/she comes under Merit Based category, detail mentioned in provision (a) of this Item, will be given concession accordingly to the said category, subject to fulfillment all conditions prescribed therefor. Moreover, the candidate has also to qualify Hifz-e-Quran test which will be conducted by the Institute while considering admission under this quota.



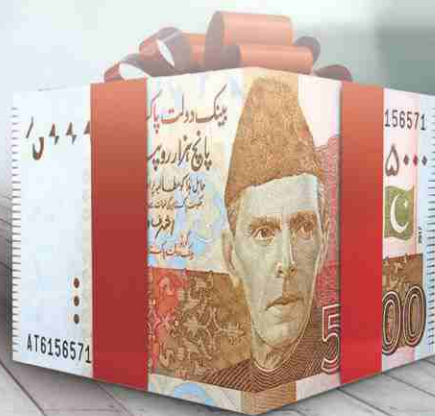
(ii) If any student would pay full fee of the whole program, i.e. altogether Five Professionals / Years, in advance, then such student will be given facility of exemption of one complete Professional/Year Tuition fee.

(iii) If any student would pay full fee of one whole Professional/Year, in advance, then such student will be given concession of 20% in Tuition fee of that Year.

Note:- For all the above concessions/scholarships, it is mandatory for the beneficiary students to be regular / punctual in studies and maintain discipline.

Rewards

One of the main mottos of the IRASP is to boost up & maintain quality of education. In order to encourage the students, IRASP has approved different scholarships/rewards to be awarded to its talented students on performance based both for academics and co/extra-curricular activities, as per following:



(I) Position Holders in Pharm-D Examinations at the Institute Level

The 1st three position holders at the Institute level through university exam results will be awarded rewards as mentioned against each position. This will be given to the position holder appeared as fresh under 1st Annual Examination (each Prof). However, results declared under 2nd Annual / Supplementary Exam (as the case may be) or the student appeared with compartment(s) will not be eligible for this reward.

1st	Cash Award of Rs.15,000/- PKR and Distinctive Certificate
2nd	Cash Award of Rs.10,000/- PKR and Distinctive Certificate
3rd	Cash Award of Rs.10,000/- PKR and Distinctive Certificate

Eligibility:

- Positions will be computed for each Professional separately based on fresh and 1st Annual Examination only.
- Student must have maintained discipline during the preceding academic year.
- Student has fulfilled the requisite attendance in the specific academic year.
- In case, two or more than two students are qualifying for the same position, similar cash award will be given to all such students, subject to fulfilling requisite criteria.

(II) Position Holders in Pharm-D Examinations at University (BZU) Level

The students of IRASP who succeed to get positions in the University (BZU) will be awarded rewards as mentioned against each position. This will be given to the position holder appeared as fresh in 1st Annual Examination (each Prof). However, results declared under 2nd Annual / Supplementary Exam (as the case may be) or the student appeared with compartment(s) will not be eligible for this reward.

Eligibility:

- Positions will be computed for each Professional separately based on fresh and 1st Annual Examination only.
- Student must have maintained discipline during the preceding academic year.
- Student has fulfilled the requisite attendance in the specific academic year.
- In case, two or more than two students are qualifying for the same position, similar cash award will be given to all such students, subject to fulfilling requisite criteria.

(III) Gold Medal Achiever in Pharm-D Examination in the University (BZU)

Gold Medalist	DESCRIPTION OF REWARD
	Cash Prize of Rs.250,000/- and Souvenir

Eligibility:

- A student, who pass the Doctor of Pharmacy degree by obtaining cumulative highest marks at the end of all five years' exam and announced "Gold Medalist" by the university (BZU).
- Student must have maintained discipline during the preceding academic year.
- Student has fulfilled the requisite attendance in the specific academic year.
- In case, two or more than two students are qualifying for the same position, similar cash award will be given to all such students, subject to fulfilling requisite criteria.

(IV) Reward for Obtaining Distinction in Co/Extra-Curricular Activities

The following rewards will be awarded to the students who obtain distinction in Co/Extra-Curricular activities, as per follows:

DISTINCTION	DESCRIPTION OF REWARD
Representation at International Level	Cash Prize of Rs.30,000/- and Distinctive Certificate
Representation at National Level	Cash Prize of Rs.20,000/- and Distinctive Certificate
Representation at Provincial Level	Cash Prize of Rs.10,000/- and Distinctive Certificate
Representation at University Level	Cash Prize of Rs.5,000/- and Distinctive Certificate
Representation at Institute (Home) Level	Distinctive Certificate

Eligibility:

- Above stated rewards will be given to only those students who participate in any authorized co/extra-curricular activity organized by the Government/HEC verified Institute / Organization / University / Research Centre after prior approval from the competent authority of IRASP.
- Students must have requisite attendance in class throughout the academic year.
- Students must have maintained discipline during the preceding academic year.

In case, two or more than two students are qualifying for the same distinction, similar reward will be given to all such students, subject to fulfilling requisite criteria.



Rules & Regulations



a) Identity Card

It is mandatory that the students must carry their institutional identity cards during the institute hours and will produce to the concerned official on demand. This ID card can be obtained from the Admin. Office on payment of Rs.300/-. In case of lost, duplicate identity card can be obtained for Rs. 500/-

b) Use of Library Books

Students must produce Library Card to the Librarian while entering in the Library. This Library Card will be issued by the Librarian office on payment of Rs. 3,000/-. All the students are expected to be very careful about usage of library books. They are not allowed to take books without getting these issued in their names. Books should be returned within stipulated time period. A fine of Rs. 50/- per day per book will be charged if books are returned late. A damaged or defaced book shall not be accepted to be returned. Instead thereto, the borrower will have either to arrange & provide the same new book or to pay price in equal amount as per market rate.

c) Use of Labs Material

Students are expected to be very careful while using Labs equipment/apparatus. In case, it is established that the equipment or apparatus or glassware is spoiled either deliberately or due to recklessness then the concerned student shall be liable to pay damages of the material as per market rate.

d) Attendance

Students shall strictly fulfill at least 75% attendance requirement to sit in the examination. Moreover, a fine of Rs.150/- shall be imposed for a leave which is availed without submitting application or intimation to office of the HOD.

e) Fee/Dues

- i. Institute fee and other dues shall be paid on the date(s) as prescribed. A fine @ Rs.100/- per day shall be charged after the due date upto 15-days. However, after 15-days, her/her name would be expelled. Such student can however apply for readmission maximum within 10-days of the date of expulsion subject to eligibility and payment of all dues/fine etc.
- ii. Dues once paid are neither refundable nor transferable in any case.
- iii. Institute has the right to increase fee structure at any time, without assigning any reason thereto, and all the students will comply the same.
- iv. In case a student is enjoying merit or need based or likewise scholarship, then he/she shall have to score and maintain his/her examination record, as prescribed and has to maintain regularity/punctuality and discipline, as required. In case any contradiction, the said scholarship shall be withdrawn without giving any notice.

f) Regulations for Examinations & Promotion to Higher Class

- i. The medium of instruction and examination will be English except for the Pakistan Studies, Islamiyat / Ethics and Translation of Quran with an option for the candidates to take the examination in Urdu.
- ii. The Examination for the degree of Doctor of Pharmacy (Pharm.D) shall consist of five professional examinations, titled First Professional, Second Professional, Third Professional, Fourth Professional and Final Professional Examination. Respective Professional Examinations shall be held twice a year termed as 1st Annual and 2nd Annual (Supplementary) examination.



Follow the Rules



- iii. The minimum number of marks required to pass the professional examination for each subject shall be fifty percent (50%) in theory and fifty percent (50%) in the Practical Examination.
- iv. A candidate who passes one or more papers but fails in the annual examination shall, if he/she so desires, can provisionally be allowed to join the next higher class till the commencement of supplementary examination. The candidate, however, shall have to pass the failed paper(s) in the supplementary examination and, in case of failure, the candidate shall be re-appeared till the last/final chance of the class in which he/she was failed.
- v. A candidate who could not pass First Professional Examination in FIVE consecutive chances, availed or un-availed, after becoming eligible for First Professional Examination shall cease to become eligible for further education in Pharmacy.
- vi. A candidate who passes all papers at one attempt as fresh and secures eighty percent (80%) or above marks in any subject then he/she will be eligible for the award of "distinction" in that particular subject. However, a candidate who although secures 80% or above marks in any subject but could not pass all subjects of that Professional Examination at one attempt will not be eligible for award of distinction.
- vii. The Professional Examination shall be open to any student who has completed one year academic courses in the said professional examination and completed 75% of the lectures in Theory and Practical classes
- viii. Every candidate shall forward to the Controller of Examinations, his/her application for admission to the examination as per schedule before the commencement of the examination accompanied by the prescribed fee

through the Executive Director/HOD office of IRASP.

- ix. If the Examination Admission Form along with fee of any candidate is not received within the due date(s) prescribed with single fee, then such candidate can also submit Examination Admission Form with double or triple fee as prescribed at the time by the University. However, after expiry of last date with triple fee then no Form will be entertained.
- x. The student shall have to pay examination fee as prescribed by the University for each Professional and each attempt.
- xi. Result card will be issued by Controller of Examinations to each Candidate after declaration of Official Notification of Result.
- xii. Rules for rechecking, offenses, and penalties on account of use of unfair means etc. shall be in accordance with the Regulations for Examinations prescribed by Bahaudin Zakariya University Multan.
- xiii. These rules/regulations are incorporated as provided under Pharm-D Examination rules 2005 and BZU examination rules. However, time-to-time amendments in the rules by these authorities will be applicable and IRASP management will not be responsible in this regard.

Note: Any of the rules can be revoked or changed at any time by the competent authority and all the concerned will comply the same.

g. Co/Extra-Curricular Activities

All the students of the Institute are supposed to participate / attend co/extra-curricular activities or events arranged by the institute and shall pay their contribution in this regard, if required. Sincere co-operation of the parents is earnestly sought in this matter.



Student Discipline



1. A student is liable to be fined or expelled from Institute if found guilty in any one or more of the following:
 - Indecent behaviour with any faculty member or officer or staff of the Institute / in class room or institute or else where.
 - Found to persuade other students to take part in any agitation, strike, quarrel, walkout or illegal sit-in.
 - Found damaging or defacing furniture, fittings or any other property of the Institute.
 - Found using of loud speaker, mega phone or likewise instruments.
 - Involved in submitting any false information or documents.
 - Using of unfair means in any exam/test.
 - Found smoking etc.
 - Found showing disobedience or found to neglect the instructions issued by any Officer, Teacher or by the Management.
2. All the students are also supposed:
 - To come in the Campus with proper dress code/uniform, as prescribed by the Institute.
 - Not to form or be associated with any political organization, whatever the name is, in the Institute. They shall not be allowed to invite any person to address the students without the prior written permission of the Management.
 - Not to receive visitors during study hours. However, special permission may be obtained in unavoidable circumstances.
 - Neither to receive nor make telephone calls during study hours, except in case of emergency with teacher's permission.
 - To observe moral & ethical values strictly.
3. Ragging, teasing, taunting or mocking in any form are strictly prohibited in the Institute.
4. Students are supposed to see the Institute's Notice Board every day.
5. All sorts of weapons are strictly prohibited inside the Institute premises.
All the students of IRASP are mandatory bound to act upon the rules and regulations exist at present or amended from time to time. If any student is involved and found guilty in any gross misconduct, shall be liable for disciplinary proceedings by the institution immediately.

Students Disciplinary Committee:

The Institute has a Students Disciplinary Committee which has been made for the purpose to investigate any issue / conflict occurred in the premises of the Institute and this committee can penalize the students, found involved in untoward incident, including expulsion, rustication, imposing fine (not exceeding Rs.10000/-) and debarring for entry in the Institute premises for a specific period (not more than 15-days in one instance). However, the aggrieved one can appeal against the penalty/ies, inflicted, to the Executive Director (Appellate Forum) of the Institute who is empowered to repeal, mitigate or to keep intact the same, which will be final. However, no penalty can be imposed without affording a chance to the concerned to be heard in person. Moreover, Disciplinary committee may also suggest fine to be imposed on the student(s) against the violation of Rules and Regulations of IRASP.



Eligibility Criteria

As per guidelines of BZU and Pharmacy Council of Pakistan, the candidates having the following qualification and marks will be eligible for admission to Pharm-D degree program:

- F.Sc. (Pre-Medical)/A Level with IBCC Equivalency with at 60% Marks.

For Admission to Pharmacy Technician (Category-B)

Matric with Science Subject i.e biology / computer / electric.
(No Age Limit)

- F.Sc./A Level or Equivalent = 08 Copies (Attested)
- National Identification Card / B-Form = 05 Copies

- Recent Passport Size Pictures = 10 Nos.
- NOC (If applicable) = Original as well as 03 Copies.
- School / College Character Certificate

- a. A student who has his/her F.Sc. other than BISE Multan or DG Khan or Sahiwal has to submit NOC in original of his/her relevant Board.
- b. All the above said documents are compulsory at the time of admission.
- c. In case any document of the student is reported fake at any stage, then the concerned would be solely responsible for the consequences.
